AGENDA APPROVED

Commissioner Jensen made a motion to approve the agenda, seconded by Commissioner Payne, motion carried.

ICRMP BALLOT

Commissioner Jensen made a motion to nominate Commissioner Vaughn Rasmussen for the ICRMP board to represent out districts in southeast Idaho, seconded by Commissioner Payne, motion carried.

BOARD OF EQUALIZATION

Commissioner Payne made a motion to approve and accept Resolution #2019-04 for the Support of the Construction Bridge Grant which will cost \$622,000 and for matching funds of \$46,000 if funding did come through on the grant, seconded by Commissioner Jensen, motion carried.

Sean Bartschi and Devin Boehme joined in on the discussion and agreed to a later date. Roy Bunderson also joined the meeting.
