The Board of Bear Lake County Commissioners met for the purposes of a work meeting on clarifying the county roads on Thursday, December 13, 2018 at 7:00 p.m. in the School District #33 Board Room in Paris, Idaho. Members present were Commissioners Vaughn N. Rasmussen, Chairman, Bradley D. Jensen, Rex L. Payne and Cindy Garner, Clerk of the Board.

Others attending were Weed Supervisor Todd Transtrum, Superintendent Scott Esquibel, Gregg Skinner and Todd Boehme from the Road and Bridge, Janene Price, Mark Parker, Nick and Nichole Smith, Mike Derricott and Pamela Harmon, The News-Examiner Reporter.

Commissioner Rasmussen stated this was not a public hearing and would take short comments, but for legal purposes to vacate or declare a road, it has to go through the notification and public hearing process which does take some time. Commissioner Rasmussen turned the meeting over to Commissioner Jensen. Commissioner Jensen stated there had been a lot of work on the 2015 map which had to be done by law by the deadline of December 31, 2015, so there was a push and it had been worked on years before by former Commissioner Conrad Michaelson. The only issue was that looking into it further, the publication notifications had some other requirements which weren't met so it was decided it would be best to work on the county roads at this time and get them updated and current for everyone's benefit in the county. Todd Transtrum has put together an electronic map that will be very useful and easy to make the needed amendments, additions or changes, after following the correct procedure depending on what action is taken. The goal would be to have one (1) map to be used by everyone and it would be updated as required and that amended or updated map would then be the map used by everyone.

Roads and public right of ways discussed were as follows: Fossil Canyon Road, Jones Canyon Road, Dry Canyon Road (Diamond Gulch), Wildlife Management Road, The Dell, Left Hand Canyon to Red Pine Road, Noveen Lane, North and South Stauffer Canyon Road, Beck Road down from Little Valley Road, Cross Over Road from Sleights Canyon Road to Paris Canyon Road, extension of Bloomington Canyon Road to Harry's Hollow, Piggott Lane, portion of Mountain Way Road, Center Lane, Sugar Loaf Road, Hunsaker Ranch Road, Immigrant Road, Indian Creek by Tubbs Hollow, Cooley Canyon, Mill Canyon Road, Bauman Road verses Bauman Lane, Wallentine Road and Miles Canyon Road. There will be further follow up on which roads will have a classification change and would require notices being sent and a public hearing.

Commissioner Jensen made a motion to adjourn the work meeting, seconded by Commissioner Payne, motion carried. Meeting adjourned at approximately 10:30 p.m.
