BUDGET HEARINGS

The Commissioners met with various elected officials and department heads to discuss their FY 2013 budget requests.

SECURE RURAL SCHOOLS RESOLUTIONS

The Clerk presented Resolutions #2012-04 and #2012-05 regarding the 2012 Secure Rural Schools payments. Commissioner Romrell made a motion seconded by Commissioner Kunz to adopt Resolutions #2012-04 and #2012-05. Motion carried.

WHEREAS, Congress enacted in 1908 and subsequently amended a law that requires that 25 percent of the revenues derived from National Forest lands be paid to states for use by the counties in which the lands are situated for the benefit of public schools and roads; and

WHEREAS, the principal source of revenues from National Forest lands is from the sale and removal of timber, which has been curtailed in recent years with a corresponding decline in revenues shared with counties; and

WHEREAS, the United States Congress recognized a need to stabilize education and road maintenance funding through predictable payments to the affected counties, and to achieve that goal enacted the Secure Rural Schools and Community Self-Determination Act of 2000 ("SRS 2000"), which was amended and re-authorized for FFY 2008 - 2011 ("SRS2008") and has been amended and re-authorized for FFY 2012 ("SRS2012"); and

WHEREAS, Title I of SRS2012 gives each eligible county the right to elect to receive either its traditional share of revenues from the National Forest lands pursuant to the Act of May 23, 1908 and Section 13 of the Act of March 1, 1911 (the "25-percent payments"), or instead to receive a guaranteed minimum share of the State payment pursuant to Sections 102(a)(1)(B) and 103 of SRS2012 (the "full county payment amount"); and

WHEREAS, an election to receive the full county payment amount is effective for federal fiscal year 2012; and

NOW, THEREFORE, be it resolved as follows:

1. Bear Lake County elects to receive its guaranteed minimum full county payment amount of its share of the Idaho SRS2012 payment pursuant to

Sections 102(a)(1)(B) and 103 of SRS2012.

WHEREAS, Congress enacted in 1908 and subsequently amended a law that requires that 25 percent of the revenues derived from National Forest lands be paid to states for use by the counties in which the lands are situated for the benefit of public schools and roads; and

WHEREAS, the principal source of revenues from National Forest lands is from the sale and removal of timber, which has been curtailed in recent years with a corresponding decline in revenues shared with counties; and

WHEREAS, the United States Congress recognized a need to stabilize education and road maintenance funding through predictable payments to the affected counties, and to achieve that goal enacted the Secure Rural Schools and Community Self-Determination Act of 2000, which was amended and re-authorized for FFY 2008 - 2011; and

WHEREAS, the United States Congress has re-authorized the Secure Rural Schools and Community Self-Determination Act for FFY2012 ("SRS2012"); and

WHEREAS, Title I of SRS2012 gives each eligible county the right to elect to receive either its traditional share of revenues from the National Forest lands pursuant to the Act of May 23, 1908 and Section 13 of the Act of March 1, 1911 (the "25-percent payments"), or instead to receive a guaranteed minimum share of the State payment pursuant to Sections 102(a)(1)(B) and 103 (the "full county payment amount"); and

WHEREAS, Bear Lake County elected in FFY 2012 to receive the guaranteed minimum full county payment amount pursuant to SRS2012 Sections 102(a)(1)(B) and 103; and

WHEREAS, an election to receive the full county payment amount is effective for all Federal Fiscal Year 2012; and

WHEREAS, any county electing to receive a full county payment amount that is \$100,000 or more must further elect to expend an amount not less than 15 percent nor more than 20 percent of its full county payment amount as project funds; and

WHEREAS, Title I, Section 102(d) of SRS2012 requires that counties electing to receive a full county payment amount of \$100,000 or more must allocate its project funds for between projects in accordance with Title II and Title III, and return the balance of project funds unspent under Titles II and III to the Treasury of the United States, and communicate such allocation to the Secretary of the United States Department of Agriculture; and

WHEREAS, Title II provides for special projects on federal lands or that benefit resources on federal lands, which projects are recommended by local resource advisory committees ("RACs"); and

WHEREAS, RACs recommend projects for consideration by the Secretary of Agriculture, with project funding supplied in whole or in part out of monies allocated for such purposes by participating counties; and

WHEREAS, counties that allocate funding to projects under Title II, and are participants in more than one RAC, may further direct that their Title II project funds be divided between different RACs according to an allocation decided by each participating county, with such funds held in the Treasury of the United States under the name of the county with a designation of the amount allocated to each RAC; and

WHEREAS, Title III provides for county projects, some of which are associated with federal lands, with Title III authorizing expenditures for search, rescue and emergency services, fire prevention and planning under the Fire wise Communities program, and development of community wildfire protection plans; and

WHEREAS, a county with a full county payment amount of \$350,000 or more may not allocate more than 7 percent of its full county payment amount for Title III projects.

NOW, THEREFORE, be it resolved as follows:

- 1. Bear Lake County has elected to receive a full county payment amount that is \$100,000 or more, and hereby allocates 15 percent of its full county payment amount for expenditure on projects under Title II and Title III. Bear Lake County will return none (zero percent) of its full county payment amount to the Treasury of the United States.
- 2. Of the percent allocated to Title II and Title III projects above in paragraph 1, Bear Lake County further allocates between such Titles for FFY 2012 (for expenditure after FFY 2012) on the following basis: 15 percent of full county payment amount for expenditure on Title II projects and 0 percent of the full county payment amount for expenditure on Title III projects.

DISASTER DECLARATION

The Board considered a loss assessment report prepared by the Bear Lake County Disaster Board of the Farm Service Agency. The report showed significant crop loss in the Bear Lake Valley due to draught and frost. Commissioner Kunz made a motion seconded by Commissioner Romrell to request that the Governor declare Bear Lake County a disaster area. Motion carried. The declaration would allow local farmers to be eligible for State and Federal programs for draught stricken areas.

SOIL AND WATER CONSERVATION GRANT SUPPORT

Lisa Transtrum asked the Commissioners to provide a letter of support for a 319 grant for erosion control on Ovid Creek. Commissioner Romrell made a motion seconded by Commissioner Kunz to write a letter of support for the project. Motion carried.

ROAD AND BRIDGE ISSUES

Greg Skinner presented his monthly report. He would like to do some blasting in the Worm Creek gravel pit. Chip sealing will start later in July. He noted that they had used a lot of dust suppressant this year due to the dry conditions.

RV PARK ROAD

Bona Miller and Cal Evans, representatives of the Bear Lake RV Park owners, were approached by the developers of Canyon Estates to upgrade a portion of their road to accommodate a new road through Canyon Estates. The road would provide a second access to Fish Haven Canyon. The cost to the RV park owners would be \$30,000 and they were reluctant to participate in the project.

BEAR LAKE WEST PROJECT

Art Fanconi, Kitty Louden and other neighbors of Bear Lake West met with the Commissioners regarding a project to create a bus turnaround and relocate the garbage containers in Bear Lake West. They felt that there should have been public notice and public input on the project. Mr. Fanconi is meeting with Bear Lake West Homeowners this weekend.

LANDFILL LOADER

Jim Betty from Caterpillar Equipment and Todd Transtrum met with the Commissioners regarding mechanical problems with the 973 loader used at the landfill. Cost to repair the older loader would be \$77,000. Mr. Betty offered a 963 loader on a lease/purchase to replace the 973 machine. They suggested that this would be a better alternative than repairing the old loader. Commissioner Kunz made a motion seconded by Commissioner Romrell to accept the lease. Motion carried.

BUDGET HEARINGS

The Commissioners met with various elected officials and department heads to discuss their proposed budgets for fiscal year 2013.

EXECUTIVE SESSION

Commissioner Romrell made a motion seconded by Commissioner Kunz to convene in an executive session per Idaho Code 67-2345(b and d) to discuss a personnel issue and medical assistance claims. All Commissioners voted yes in a roll call vote.

Following the executive session Commissioner Romrell made a motion seconded by Commissioner Kunz to act on medical indigent claims as follows:

ROAD HEARINGS

The Commissioners continued the hearings that were held June 26 and 27, 2012 regarding updating the County Highway System. The Commissioners reviewed public comments that had been received since the hearings. Commissioner Romrell made a motion seconded by Commissioner Kunz to close the hearing. Motion carried. Commissioner Rasmussen will summarize the public input received during the hearings.

GEM PLAN UPDATE

Grayden Staley and Tim Marks form the Gem Plan updated the Commissioners on the County's health insurance plan. They presented information on the County's loss ratios for the past year. They reported that the rate increase for next fiscal year would be 5%. They also stated that the financial health of the Gem Plan was excellent.

ROAD AND BRIDGE WORK DONE FOR CITIES

Meeting adjourned subject to recall by the Chairman or his order.

Greg Skinner reported on work that the County had done for the Cities. He reported that they had done work for Paris, St. Charles and Bloomington. He said he would invoice the Cities accordingly.

The Board of Bear Lake County Commissioners met in an emergency meeting on July 3, 2012, beginning at 9:00 A.M. in the Bear Lake County's Sheriff's Office in Paris, Idaho. Members present were Vaughn N. Rasmussen, Chairman, Montain D. Kunz, DeMar Romrell and Kerry Haddock, Clerk of the Board.

Brent Bunn, Sheriff, Roger Jones, Attorney, City Mayors Reed Peterson, Roy Bunderson and Alan Michaelson. Alan Eborn, Dennis Duehren, Steve Higgins, Bill Stock, Lisa Transtrum, Greg Skinner and Brad Jensen also attended the meeting.

The purpose of the meeting was to discuss the extreme fire danger in the County and consider steps to minimize the dangerous situation. Following a lengthy discussion, it was decided to pass an emergency Ordinance to ban fireworks in the County until further notice. This will allow local law enforcement officials to issue tickets to offenders rather than arresting them under State Law. Commissioner Romrell made a motion seconded by Commissioner Kunz to approve the emergency Ordinance. A press release and Public Notice will be prepared and distributed throughout the County immediately and the County Attorney will prepare the Ordinance.

COUNTY OF BEAR LAKE, STATE OF IDAHO

ORDINANCE No. 2012-1

AN ORDINANCE PROHIBITING USE OF CERTAIN FIREWORKS AND MAKING SAID VIOLATION AN INFRACTION.

Whereas, the County of Bear Lake has an interest in maintaining the safety and health of its citizens and their property; and

Whereas, the County of Bear Lake has recently experienced extraordinary weather conditions causing an increase in the risk of wildfires in all areas of the County of Bear Lake; and

Whereas, neighboring areas have recently experienced extensive property damage from wildfires raising concern for the public health and well being of society, as well as concern for significant property damage risk to the citizens of the County of Bear Lake; and

Whereas, the Bear Lake County Commissioners met with local officials and members of the public in an open meeting called on an emergency basis on July 3, 2012, to discuss the dangers facing the citizens of Bear Lake County; and

Whereas, the Bear Lake County Board of Commissioners have determined that emergency conditions posing extreme risk from wildfires exists, and that use of fireworks in any area of Bear Lake County constitutes a severe fire threat based on the vegetative conditions;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF BEAR LAKE, STATE OF IDAHO AS FOLLOWS:

Section 1: Definitions: For purposes of this ordinance the following definitions shall apply:

a. Fireworks: is defined according to the same definition found in Idaho Code Section 39-2602(3), and shall include anything that explodes or leaves the ground..

Section 2: Public Intoxication Prohibited: Until further action by the Board of Commissioners for Bear Lake County or until 180 day of the date of this Ordinance, whichever comes first, it shall be unlawful for any person or persons to use Fireworks as defined above within Bear Lake County.

Section 3: Violation: Any person found violating any provision of this Ordinance shall be guilty of an infraction, punishable by a set penalty of\$100.00 which shall include all usual and customary court costs. Any person or entity violating this ordinance shall be liable to Bear Lake County and/or its subdivisions for all costs and expenses incurred as a result of fires caused by such violation and/or for other costs incurred as the result of efforts to limit the damage caused by such violation(s).

Section 6: Severability: If any provision of this Ordinance is determined by a court of competent jurisdiction to be otherwise void or unenforceable, all remaining sections shall be considered enforceable.

Section 7: This Ordinance shall be in full force and effect immediately when signed because of the emergency nature of the current fire conditions.
